THE OPPORTUNITY

The Chambers Plan *can collect membership dues on your behalf*. **You simply authorize us to offer monthly dues to members who participate in the Chambers of Commerce Group Insurance Plan.** We collect your dues right on your members' group insurance billing statements.

It's a great alternative to the traditional one-time annual billing and makes it easier for your members to stay with you year after year. Every month firms lose their group coverage because they haven't renewed their Chamber membership. How many of these would keep their coverage and membership if we made it easier for them to pay? How many new firms would join your organization and the Plan if we took away the barrier of one large lump sum up front?

HOW IT WORKS

Authorize us to collect membership dues on your behalf by completing the form on the next page. We can offer the option to members who are insured now, and to prospects considering the Plan. Your members can accept or decline the offer, as they see fit.

For those that choose the option, we will bill and collect monthly membership dues via their regular group insurance billings. The monies we collect are sent on to you on the 15th of each month, when we send you your regular Chamber Plan administration fees.

You pick the levels / categories of membership to best match your existing schedule and we will collect monthly dues, including GST/HST (i.e. \$10, \$22, etc.). For example, if you normally charge \$100 a year plus GST/HST for one category of firms, you may want to charge them \$10 in monthly dues instead.

Remember that we are talking about monthly memberships, cancelable at any time, not prorated annual billings. The monthly membership option is available to your member firm so long as it remains insured under the Chambers of Commerce Group Insurance Plan.

HOW DO YOU GET STARTED?

Simply fill out the enrolment form on the last page and fax, email, or mail the completed form to our office. We will set up the schedule you provide on our system and let your local marketing advisor know the new due structure is in place.
